



## Purchase and Policy Agreement for a Minor Guest

A Minor Guest (under 18) must be hosted by an adult Member. As the Member Host of a minor, you agree to remain on club property for the duration of the guests visit, and are solely responsible for your guest's safety, supervision and conduct.

There are many amenities and activities within HFAC that carry inherent risks. In addition to your assumption of responsibility for a minor guest while within the club, that child's parent or legal guardian must complete and sign the **Liability Waiver and Policy Statement for Minor Guests of HFAC**.

Please read the following additional reminders of HFAC policies:

- Minor Guests will not have had the opportunity to complete HFAC's Teen Fit or Self Manager Programs, and thus do not enjoy the benefits of these programs.
- HFAC's pools are primarily for fitness activities and there is no Lifeguard on Duty for many of our open hours. As a further reminder, note that State Law requires that minors 14 and under be directly supervised by an adult when in a swimming pool. An adult should be within arms-reach of non-swimmers and developing swimmers, even if the child is using a floatation device.
- Please download or request a copy of the additional **HFAC Rockwall Liability Waiver** to enjoy HFAC's Open Climb hours. This must also be completed and signed by the minor guest's parent or guardian.
- One Membership may not host more than 4 guests in any single day.
- Guests of any age may not visit HFAC more than twice in one month. For more frequent visits, please inquire with our Membership Department about short-term Memberships and HFAC's Member Referral bonuses.

## Liability Waiver & Policy Statement for Minor Guests of HFAC

**This form must be read, completed and signed by the Parent or Legal Guardian of any minor guest of Hawthorn Farm Athletic Club.**

Any guest of HFAC under the age of 18 must be hosted by an adult club Member who agrees to remain on club property while your child visits. This host Member further agrees to be solely responsible for your child's safety, supervision and conduct. There are many amenities and activities within HFAC that carry inherent risks. Further, the club places a high standard on creating an enjoyable and positive environment for all patrons. We thank you in advance for discussing this with your child and requesting they listen to all directions from Club employees or their hosts.

HFAC's pools are primarily for fitness activities and there is no Lifeguard on Duty for many of our open hours. State Law requires that minors 14 and under be directly supervised by an adult when in a swimming pool and your child's host will be accepting this responsibility. You or your child's host must be within arms-reach of your child if s/he is a non-swimmers or developing swimmers, even if the child is using a floatation device.

Please download or request a copy of the additional **HFAC Rockwall Liability Waiver** if your child is planning to enjoy HFAC's Open Climb hours with their host.

Guests of any age may not visit HFAC more than twice in one month. For more frequent visits, please inquire with our Membership Department about short-term Memberships and HFAC's Member Referral bonuses.

**LIABILITY WAIVER:** As the parent or legal guardian of the minor named below, I understand that my child's use of Hawthorn Farm Athletic Club may involve certain potentially dangerous activities. These include but are not limited to stretching, running, jumping, games, swimming, strenuous aerobic exercise, and other activities including cardiovascular exercises which may result in my child's heart rate increasing substantially. I acknowledge and accept that the activities are inherently physically demanding and that amenities available at the club carry inherent risks.

In consideration of the club permitting my child to use the club's facilities, or to participate in the activities, for myself and on behalf of my child, other heirs, family members, executors, administrators and assigns, I hereby knowingly and willing assume all risk of physical, emotional and economic harm which may occur as a result of my child's use of Hawthorn Farm Athletic Club facilities and/or participation in any activity. I also release shareholders, employees, instructors, and agents from any and all losses, costs, expenses, damages, fees, attorney's fees, and liability which may result from my child's use of Hawthorn Farm Athletic Club 's facilities, and/or participation in any activity.
